
CONTEST RULES AND REGULATIONS THE CKDO / BINGO GIVEAWAY

1. The CKDO BINGO contest runs Monday, March 1 to Friday, March 12, 2010, inclusive. (contest period).
2. No purchase necessary.
3. To enter, pick up a CKDO Bingo card at our CKDO studios, 1200 Airport Blvd, Suite 207 in Oshawa or print off a card by visiting www.ckdo.ca. Between Monday, March 1 and Friday, March 12, listen for CKDO to play songs that appear on your CKDO Bingo card. When you hear a song that appears on your CKDO Bingo card, write down the date and time you heard the song in the space provided. Every single line completed on your card (vertical, horizontal, diagonal) is worth one entry in the Grand Prize draw.
4. To be eligible to win, all qualifying entries must be received at our CKDO studios (via fax, e-mail, drop off or by mail) by 5PM on Friday, March 19, 2010. Qualifying entries may be emailed to contest@ckdo.ca. The email must include the winning line's correct songs and the hour in which the songs were played.
5. Only one entry per person. Multiple entries will be discarded.
6. Contest is open to residents of Canada, excluding Quebec, eighteen (18) years of age or older, excluding employees of CKDO, Durham Radio Inc. ("DRI"), and their respective advertising and promotional agencies, their immediate family members (defined as spouse or spousal equivalent, mother, father, brother or sister) and any persons residing in their respective households (referred to as "the releasees").
7. Any person who has won a contest on CKDO within the last thirty (30) days is not eligible to win.
8. All complete and correct entries are eligible for the random Grand Prize draw. Chances of winning depend upon the total number of entries received. The decision of the Contest judges is final. The prize package must be accepted as awarded. No portion of the Grand Prize is transferable. All dates, unless otherwise changed by the Contest organizers, are fixed. 10. Grand Prize: One grand prize will be awarded, consisting of a trip for two to Montreal including first class Via Rail transportation and two nights hotel accommodation.
